Storer Enterprises Inc. is a 24 hour company and must have drivers available at all times to respond to police calls, private calls, and other types of service. All drivers work a set 40 hour schedule during the week and rotate “on call” work during the nights, weekends, and holidays. An “on call” driver may live in the area and take a truck home during the “on call” shift. If the driver does not live in the area, then he/she may sleep at the office and remain in the area during the “on call” shift. The office contains a full bedroom, bathroom, and kitchen that may be used by the drivers who live out of the area. All “on call” work will be paid out at time and a half, provided that the driver has worked 40 hours during the week or pay period.

One area of particular concern is the use of chains and straps while in tow, because not using these practices on every vehicle towed could be extremely hazardous to oneself and others. All drivers are required to use safety chains on every vehicle towed and dolly straps when using the dolly system.
